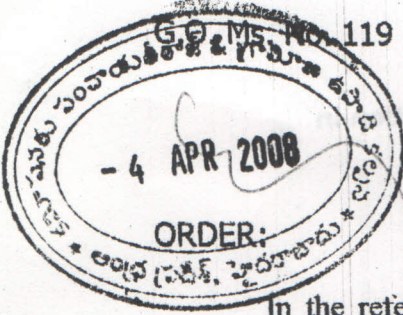

Delegation of powers under section 260 (1) of the Andhra Pradesh Panchayat Raj Act, 1994 - Removal of Sarpanch/Upa-Sarpanch/Member of Gram Panchayat under section 249 of the Andhra Pradesh Panchayat Raj Act, 1994 - Withdrawal of appeal powers from the Commissioner, Panchayat Raj - Orders - Issued.

In the reference read above, Government in exercise of powers conferred by section 260 (1) of the Andhra Pradesh Panchayat Raj Act, 1994 authorised to exercise the appeal powers to the Commissioner, Panchayat Raj, under sub-section (7) of section 249 of the said Act against the orders of the District Collector passed under sub-sections (1) and (4) of section 249. Further Government can review any orders under sub section (3) of section 264 of the Andhra Pradesh Panchayat Raj Act and a large number of revision petitions have been received by the Government. Therefore, after careful examination of the matter and to avoid unnecessary delay at various levels, the Government under section 260 (1) of the said Act hereby withdraw such delegated powers with immediate effect.

2. Accordingly, the following notification will be published in the Andhra Pradesh Gazette, date 04-04-2008:

NOTIFICATION

In exercise of the powers conferred by section 260 (1) of the Andhra Pradesh Panchayat Raj Act, 1994 Act No. 13 of 1994 the Government, hereby withdraw the delegated powers hitherto exercised by the Commissioner, Panchayat Raj under sub-section (7) of section 249 of the said Act, issued in G.O. Ms. No. 693, PR, RD & R (PTS.II) Department, dated 28-10-1995 with immediate effect.

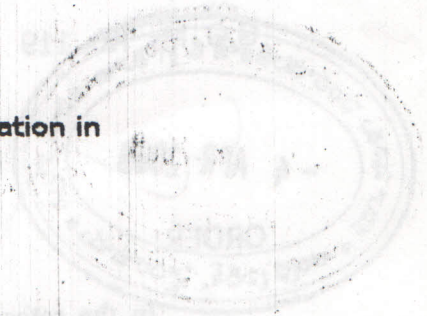
