FROM FAIRS AND FESTIVALS UNDER THE A.P. PANCHAYAT
RAJ ACT, 1994.

In exercise of the powers conferred by sub-section (1) of Section 268 read
with section 114 of the Andhra Pradesh Panchayat Raj Act, 1994, (A.P. Act
No.13 of 1994) the Governor of Andhra Pradesh hereby makes the following
rule relating to apportionment of income derived from fairs and festivals.

RULES

The income obtained from the fairs and festivals in any Gram Panchayat area classified under section 114 of the Andhra Pradesh Panchayat Raj Act, 1994 (A.P. Act No.13 of 1994) shall be apportioned as follows :-

1. In the case of fairs and festivals classified as appertaining to the Gram Panchayat, the entire income shall be credited to the funds of the Gram Panchayat.
2. In the case of fairs and festivals classified as appertaining to the Mandal Parishads the net income shall be apportioned between the Mandal Parishad and the Gram Panchayat equally.
3. In the case of fairs and festivals classified as appertaining to the Zilla Parishad, the net income shall be apportioned among the Zilla Parishad, the Mandal Parishad and the Gram Panchayat (at the rate of 25 per cent, 37.5 per cent, and 37.5 per cent, respectively.
