1.	Establishment	-	30%
2.	Sanitation	-	15%
3.	Street Lighting	-	15%
4.	Water Supply	-	15%
5.	Roads and Drains	-	20%
6.	Miscellanies Expenditure	-	05%

- 2. In the G.O., 2<sup>nd</sup> read above, orders issued for preparation of Mandal and Gram Panchayat Development Plan in the State in the context of MoPR guidelines and in view of the guidelines of 'Smart Village' Programme.
- 3. In the reference  $3^{rd}$  read above, the Commissioner, Panchayat Raj & Rural Development, A.P., has submitted proposals for amendment of G.O.,  $1^{st}$  read above, in the context of preparation of Mandal Development Plan and GP Development Plan requesting expenditure on developmental and social sectors.
- 4. After careful examination of the proposal of Commissioner, Panchayat Raj & Rural Development, A.P., and in partial modification of orders issued in G.O.,  $1^{st}$  read above, the Government, hereby modify the provisions for sanction of Budget by the Gram Panchayat for performing the obligatory functions as below:

- 5. In respect of item No.3 above, in Street Lighting, Gram Panchayats where LED conversion took place, shall utilize the 15% portion of funds towards payment of CC Charges. The balance available after payment of CC Charges, shall be utilized for Sanitation/Drinking Water works/Roads and Drains.
- 6. The Commissioner, Commissioner, Panchayat Raj & Rural Development, A.P., Vijayawada/ the Collectors (Panchayat Wing) shall take necessary action accordingly.
