ORDER:

In the reference second read above, the Commissioner, Panchayat Raj & Rural Development has informed that, the District Collector, West Godavari District has submitted a proposal for underground drainage system in 101 villages of West Godavari District has been approved by him vide his letter No.1926/EGS/DEE(T)/2015, Dated:17.07.2015 with instructions to not to exceed 50% funds under MGNREGS and the payment for the meaterial component shall be allowed only after the accruing propotionate wage component.

2. The Commissioner, Panchayat Raj & Rural Development further informed that, the District Collector has stated that, the works have been started on the basis of a ratio of 70% from MGNREGS and 30% by way of public contribution in the selected 101 village of West Godavari District and that the works are at different states of construction, and proposed to relax the existing ratio of 50:50 to 70:30 i.e., 70% from MGNREGS funds and 30% from Public contribution funds in the above selected 101 villages.

3. Government after examining the matter, and in relaxation of orders issued in G.O. first read above, hereby permit the Collector & District Magistrate, West Godavari to take-up under-ground drainage and drinking water pipe line works with the ratio of 70:30 instead of 50:50 ratio i.e., 70% from MGNREGs funds and 30% from public contribution (Local bodies) in these 101 villages only.

4. The Collector & District Magistrate, West Godavari shall ensure all the further works i.e., other than the works mentioned in the para three above shall be as per the guidelines issued in the reference first read above.
